

Chulalongkorn University Announcement

Regarding applications for students in the Bachelor of Science in Architectural Design (International Program), Faculty of Architecture for the 2024 academic year (International Admission)

Chulalongkorn University is now accepting Applications for Students in the Bachelor of Science in Architectural Design (International Program), Faculty of Architecture for the 2024 academic year (International Admissions). Application process is as follows.

1. Application Requirements

- 1.1. Applicants do not hold Thai citizenship and have completed high school or passed an equivalent high school standard test or be currently in their final year of high school (Grade 12 in the US system or Year 13 in the British system).
- 1.2. An applicant from abroad must have a high school certificate or have passed the high school equivalent standard test (GED, IGCSE), must have the Equivalence Certificate from High School Certificate Equivalency System, (http://www.hsces.atc.chula.ac.th/)
- 1.3. Applicants must submit all of the following 3 (three) documents, one of each category, in which at least 2 out of 3 score results must meet the requirements.
 - 1.3.1. English: Applicants must achieve the prescribed minimum score in one of the following English Proficiency tests:

- TOEFL (Internet-based)	not lower than 79	or
- IELTS	not lower than 6.0	or
- SAT (Evidence-Based Reading and Writing)	not lower than 450	or
- CU-AAT (Verbal)	not lower than 400	or
- CU-TEP	not lower than 80	

1.3.2. Mathematics: Applicants must achieve the prescribed minimum score in one of the following Mathematics Proficiency tests:

- CU-AAT (Maths)	not lower than 550	or
- SAT (Maths)	not lower than 570	or
- Mathematics on NCEA New Zealand	Merit or Excellence Level	

1.3.3. Test of Aptitude in Design: CU-TAD with minimum of 50%

1.4. Applicants who meet only 2 out of 3 requirements from item 1.3 must still achieve the minimum score in item 1.4.

1.4.1. Applicants must achieve the prescribed minimum score in any one of the following English Proficiency tests:

- TOEFL (Internet-based)	not lower than 61	or
- IELTS	not lower than 5.5	or
- New SAT (Evidence-Based Reading and Writing)	not lower than 410	or
- CU-AAT (Verbal)	not lower than 360	or
- CU-TEP	not lower than 61	

1.4.2. Applicants must achieve the prescribed minimum score in any one of the following Mathematics Proficiency tests:

- CU-AAT (Maths)	not lower than 500	or
- New SAT (Maths)	not lower than 530	or
- Mathematics on NCEA New Zealand	Achieved Level	

1.4.3. Test of Aptitude in Design: CU-TAD with minimum of 45%

Applicants who wish to apply using New SAT (Maths) and New SAT (Evidence-Based Reading and Writing) or CU-AAT (Maths) and CU-AAT (Verbal) must submit the scores of both parts tested on the same date.

The official score report of the tests in 1.2.1, 1.2.2 and 1.2.3 or 1.3.1, 1.3.2 and 1.3.3 is valid only when the tests were taken not more than two years of the application deadline.

Foreign applicants may be considered for a waiver of English proficiency requirements with sufficient proof and relevant experiences, whose secondary education (high school) took place in an accredited school where is a principal language of instruction for at least three years prior to this application in a native English-speaking country listed below:

Each case will be reviewed individually and the School reserves the right to request applicants to further satisfy English proficiency requirements if deemed necessary.

- 1.5. The required format of the portfolio is a digital PDF file not exceeding 50 MB, stored and shared online by the applicant then submitted as a URL link in the online application form. The portfolio size is A4 with no more than 20 pages including covers.
- 1.6. All applicants must have a history of good behavior and agree to abide strictly by existing and any further University regulations, codes and policies.

2. Number of Available Places

The Bachelor of Science in Architectural Design (International Program) is authorized to admit up to 8 (eight) qualified applicants.

3. Application Schedule and Application Fee

3.1 Application Schedule

3.1.1 Apply online at http://www.cuinda.com. There are two rounds of application as follows:

First round application: 25th December 2023 – 5th February 2024

Second round application (if any): 20^{th} March – 10^{th} May 2024 (The second round of application will take place on the condition that the announced number is not met in the first round.)

3.1.2 Application Fee Payment

For the first-round application, please pay the fee between 25th December 2023 – 5th February 2024 For the second-round application (if any), please pay the fee between 20th March – 10th May 2024 The applicants may pay the non-refundable 1,000-baht application fee through Kasikorn Bank, Siam Square Branch, account name: คณะสถาปัตยกรรมศาสตร์ จุฬาลงกรณ์มหาวิทยาลัย, account number: 041-8-23379-6. The payment can be done at the bank or through mobile banking with the type of credit cards showing Mastercard and VISA card logo only. Please upload the receipt for

application fee (1000 baht) to website http://www.cuinda.com.

3.2 Application Fees

The application fee is 1,000 Thai baht (transaction fees and surcharges not included).

4. Application Process and Package

4.1 Application Process

Applicants who meet all requirements listed in item 1 must apply online through the website as detailed below.

4.1.1. Complete the application form at http://www.cuinda.com.

4.1.2. Scanned and upload the pdf files of certified copies of required documents in item 4.2. through http://www.cuinda.com

4.1.3. Validate the form data click "save" then "submit" the form (the applicant cannot make any change after the form has been submitted).

4.1.4. Transfer a non-refundable application fee of 1,000 baht to Kasikorn Bank account number 041-8-23379-6 (account name: คณะสถาปัตยกรรมศาสตร์ จุฬาลงกรณ์มหาวิทยาลัย) or make a payment by credit cards showing Mastercard and VISA card logo only. Please upload the receipt for registration fee (1000 baht) to website http://www.cuinda.com.

4.2 Application Package

Applicants must complete the application form in full and ensure that all information given is true and correct. All application forms must be accompanied by the following:

- Three one-inch (1") photographs
- Academic transcript(s)
- Copies of exam results as specified in items 1.2 and 1.3
- Enrollment certificate (only for those who have not yet fulfilled all requirements for a high school diploma/certificate)
 - A copy of the applicant's passport
 - Portfolio according to item 1.4

The applicants must ensure that all documents listed in item 4.2 are submitted otherwise the Faculty of Architecture will not consider the application under any circumstances.

5. Application Process Details

5.1. First Round Application

5.1.1. Announcing Applicants Qualified for Interview

The faculty of Architecture will announce applicants qualified for interview on 12th February 2024 on the website http://www.cuinda.com.

5.1.2. Interview (Online)

Applicants qualified for an interview will be examined online on 17th February 2024. If an applicant does not report for interview, that applicant will be disqualified.

5.1.3. Announcement of Applicants Who Have Passed the Interview

The faculty of Architecture will announce applicants who have passed the interview as well as details on how to confirm acceptance of offer of place on 26th February 2024 on the INDA website (http://www.cuinda.com).

5.1.4. Accepting Offer of Place and Paying the Admission Confirmation Fee

Applicants who have passed the interview must report to accept offer of place and make the admission confirmation fee payment between $1^{st} - 7^{th}$ March 2024 (the confirmation fee is about 80,000 in Thai baht). If an applicant fails to do so by the appointed time, they will be assumed to have rejected the offer of place.

5.1.5. Announcement of Additional Qualified Applicants (If Any)

The faculty of Architecture will announce additional applicants who have passed the interview on the INDA website (http://www.cuinda.com). Additional applicants who have passed the interview must report to accept offer of place and pay the admission confirmation fee between 8^{th} – 12^{th} March 2024 (the confirmation fee is about 80,000 in Thai baht). If an applicant fails to do so by the appointed time, they will be assumed to have rejected the offer of place.

5.1.6. Announcement of Applicants who have Confirmed Acceptance of Offer of Place and Paid for the Admission Confirmation Fee

The faculty of Architecture will announce applicants who have confirmed acceptance of offer of place and paid for the admission confirmation fee by email on 4^{th} – 14^{th} March 2024.

Successful applicants who have confirmed acceptance of offer of place and paid for the admission confirmation fee will not be eligible for the second-round application. The INDA program reserves the right not to refund the application fee to applicants.

5.2. Second Round Application (If Any)

The second round of application will take place on the condition that the announced number is not met in the first round.

5.2.1. Announcing Applicants Qualified for Interview

The faculty of Architecture will announce applicants qualified for interview on 17th May 2024 on the website http://www.cuinda.com.

5.2.2. Interview (Online)

Applicants qualified for an interview will be examined online on 22nd May 2024. If an applicant does not report for interview, that applicant will be disqualified.

5.2.3. Announcement of Applicants Who Have Passed the Interview

The faculty of Architecture will announce applicants who have passed the interview as well as details on how to confirm acceptance of offer of place on 30th May 2024 on the INDA website (http://www.cuinda.com).

5.2.4. Accepting Offer of Place and Paying the Admission Confirmation Fee

Applicants who have passed the interview must report to accept offer of place and make the admission confirmation fee payment between 4^{th} – 10^{th} June 2024 (the confirmation fee is about 80,000 in Thai baht). If an applicant fails to do so by the appointed time, they will be assumed to have rejected the offer of place.

5.2.5. Announcement of additional qualified applicants (if any)

The faculty of Architecture will announce additional applicants who have passed the interview on the INDA website (http://www.cuinda.com). Additional applicants who have passed the interview must report to accept offer of place and pay the admission confirmation fee between $11^{th} - 12^{th}$ June

2024 (the confirmation fee is about 80,000 in Thai baht). If an applicant fails to do so by the appointed time, they will be assumed to have rejected the offer of place.

5. 2. 6. Announcement of Applicants who have Confirmed Acceptance of Offer of Place and Paid for the Admission Confirmation Fee

The faculty of Architecture will announce applicants who have confirmed acceptance of offer of place and paid for the admission confirmation fee by email between $11^{th} - 12^{th}$ June 2024.

6. Announcement of Applicants with the Right to Study (from the first and second round applications)

Chulalongkorn University will announce applicants with the right to study the Bachelor of Science in Architectural Design (International Program) for the 2024 academic year (international round) on 20th June 2024 a INDA website (http://www.cuinda.com).

7. Conditions of Study

7.1 An individual must have completed Mattayom 6 or equivalent to be qualified to register as a student of Chulalongkorn University. Should it emerge that applicants with right to study have found to have provided false information in the application or false evidence in support of the application, their right to study will be rescinded. The INDA program reserves the right not to refund the application fee and the admission confirmation fee to applicants.

7.2 Individuals who have completed their education at an international school or a foreign school that was not certified by the Ministry of Education must have their qualification certified by the Council of University Presidents of Thailand as being equal to a qualification according to the Ministry of Education's Basic Education Core Curriculum.

7.3 Should it emerge that applicants with right to study have found to have provided false information in the application or false evidence in support of the application, their right to study will be rescinded. The applicant may also face criminal charges.

8. University Fees and Extra Surcharges

University fees and surcharges will be charged according to announcements by Chulalongkorn University.
